About the Alumni Jobsite

The **HKUDAA Alumni Jobsite** is hosted by The University of Hong Kong Dental Alumni Association (HKUDAA) on its website, courtesy of the Knowledge Transfer Unit of the Faculty of Dentistry, The University of Hong Kong, as a free service, for alumni of the HKU Faculty of Dentistry only. The site allows Faculty alumni to advertise job vacancies directly to each other, but related only to alumni clinics or practices. Jobs related to charities, government, universities, and professional organisations may also be allowed; otherwise, no third parties or non-job-related services or advertising/marketing are allowed. The HKUDAA will vet applications, verify alumnus/a status, and determine web posting times and arrangements.
